The boxing industry is progressively giving way to other sports entertainment offers in the world. Contributes to this, among many factors:

The cannibalism of promoters and television stations, - real power of boxing

WBA must improve its economy

Expanding its ordinary income generation capabilities across the Regions - which would promote their growth under the premise of a single government, a single governance -; and positioning the brand as a global "player".

With this, the foundations can be laid to diversify WBA's economy

Advance in the construction of a global project that allows it to grow as a vanguard player in the Sports and Entertainment Industry from a more solid base.

We propose holding regional conventions or summits of the WBA.

The Regional Convention is a tool that will help revitalize WBA processes and programs

It will relaunch the international presence of WBA and its Regions

With this first step, we propose to create, together with the Region, a new reality for the benefit of the entire community.



The WBA Regional Convention is an event organized by the WBA Regional Office, in partnership with the WBA Headquarters.

Goals

Bring together members of the local organization, promoters, boxers, local boxing legends, authorities and personalities, suppliers, sponsors and partners, to share the balance of the annual work of the regional office, and announce the objectives set for the next annual exercise.



Opportunities

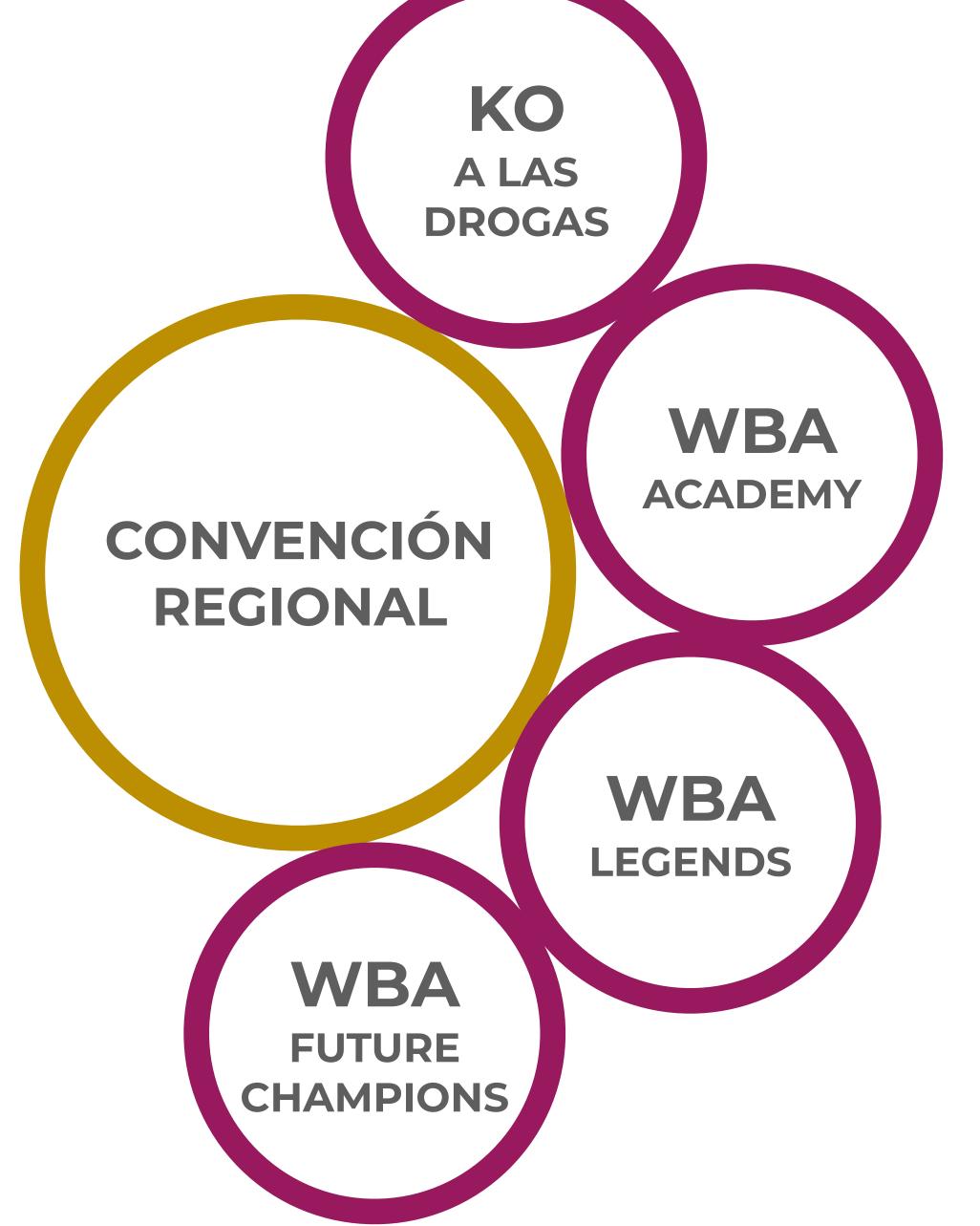
It will offer participants the possibility of sharing various experiences around sport, through the different WBA programs.

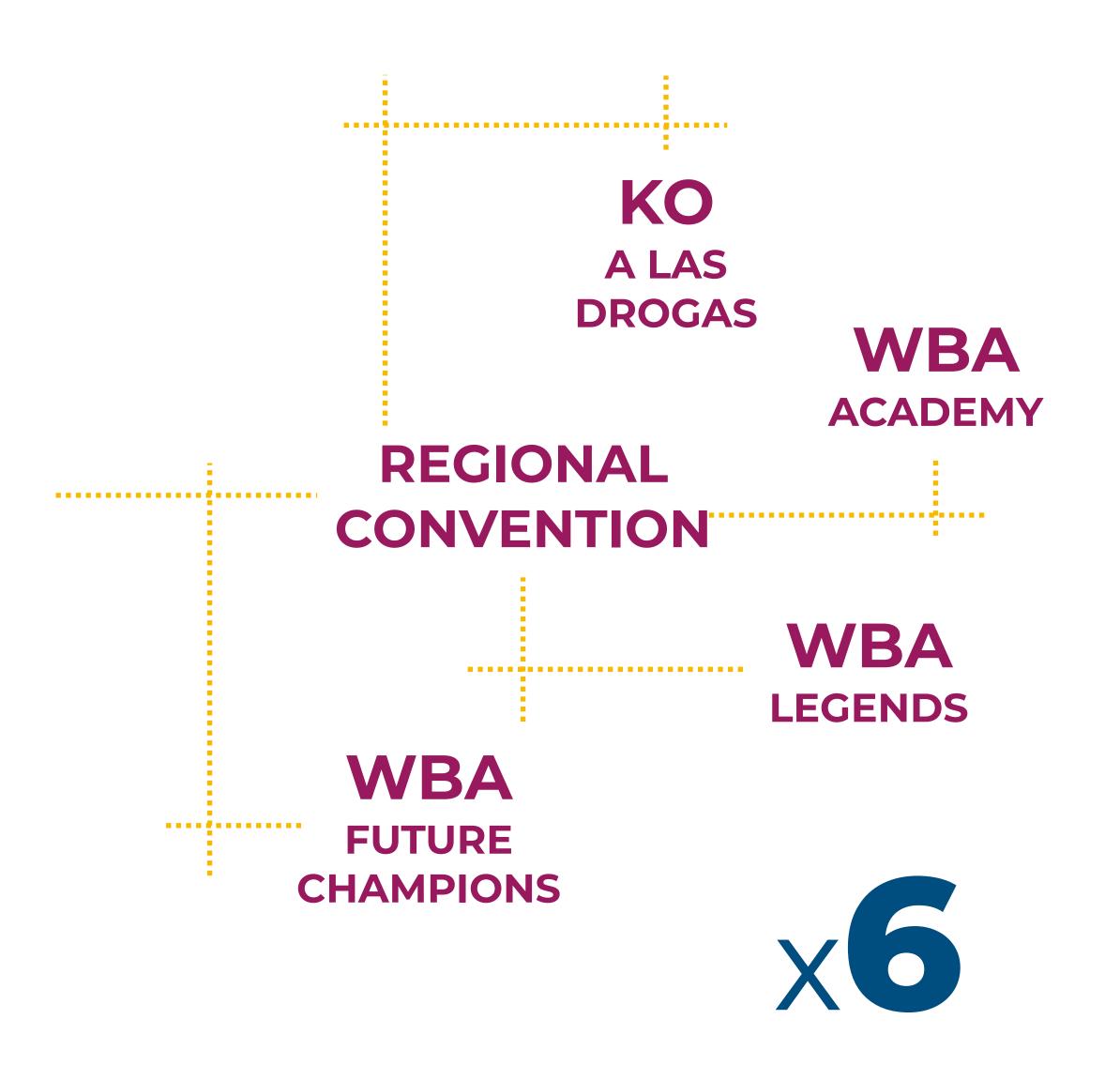

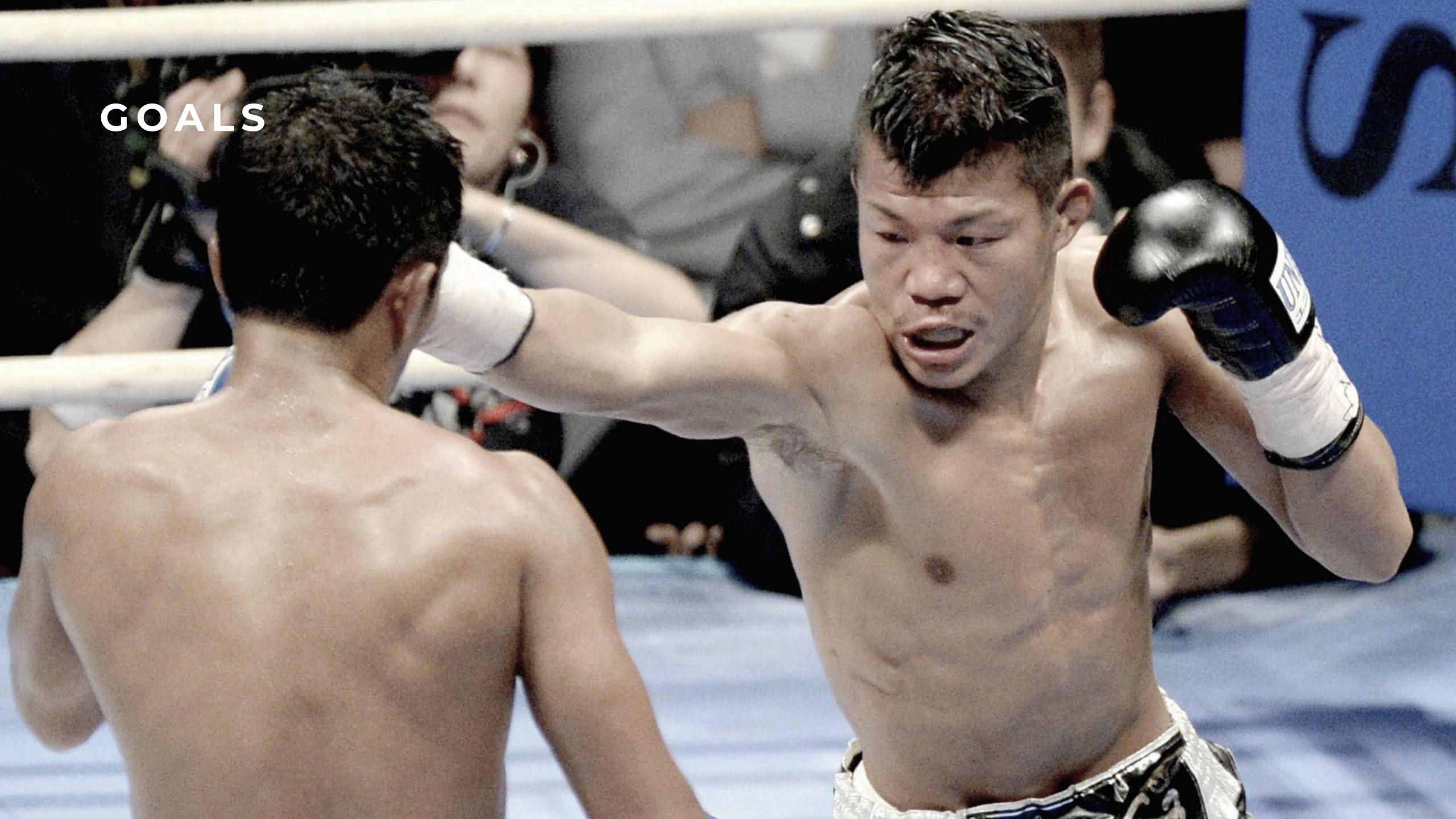

REGIONAL DEVELOPMENT

Objectives of the Regional Convention

Promote the development of the region

Definition of strategic growth zones for the Region and the WBA

Relationship and lobbying with national authorities and/or potential investors

Signing of alliances and agreements with local actors (government authorities, universities, federations, clubs, NGOs, promoters, etc.) for the training of specialized boxing personnel through the WBA Academy and Future WBA Champions programs

REGIONAL DEVELOPMENT

Signing of contracts with local promoters for the holding of boxing events in countries of strategic interest for the Region and for the WBA

Link management of international promoters with local promoters

Signing of regional and/or global sponsorship contracts

Content creation for WBA's regional and global platforms

Production and marketing of content for regional or global television networks

REINFORCE WBA PRESENCE IN THE FIVE CONTINENTS

Strengthen the presence of the WBA in the Regions, through a structured global plan that brings boxing actors closer to the WBA's global effort.

Move the global structure of the WBA

Dynamize the Region

Generate competitive spaces that contribute to raising the quality of boxing

Promote the emergence of new figures for sport

Generate pressure on the rankings

Promote the appearance of local promoters

Generate economy for the region and the central office

Generate content for promotional and commercial purposes.



STIMULATE THE PRODUCTIVITY OF WBA REGIONS

Making the WBA Regional Convention must achieve:

Build with the region a productive space that brings shared economic and sporting benefits.

Increase income from licenses (new or renewal) of promoters, officials, judges, etc.

Generate income from registration in seminars for judges, officials, doctors, etc.

Generate income from fees for regional, continental and/or world titles.

Promote the marketing of advertising spaces and/or local and/or global sponsorship agreements for the event, for the regional office and for WBA

Establish a commercial space for the direct sale of merchandising associated with the WBA and WBA Region brand

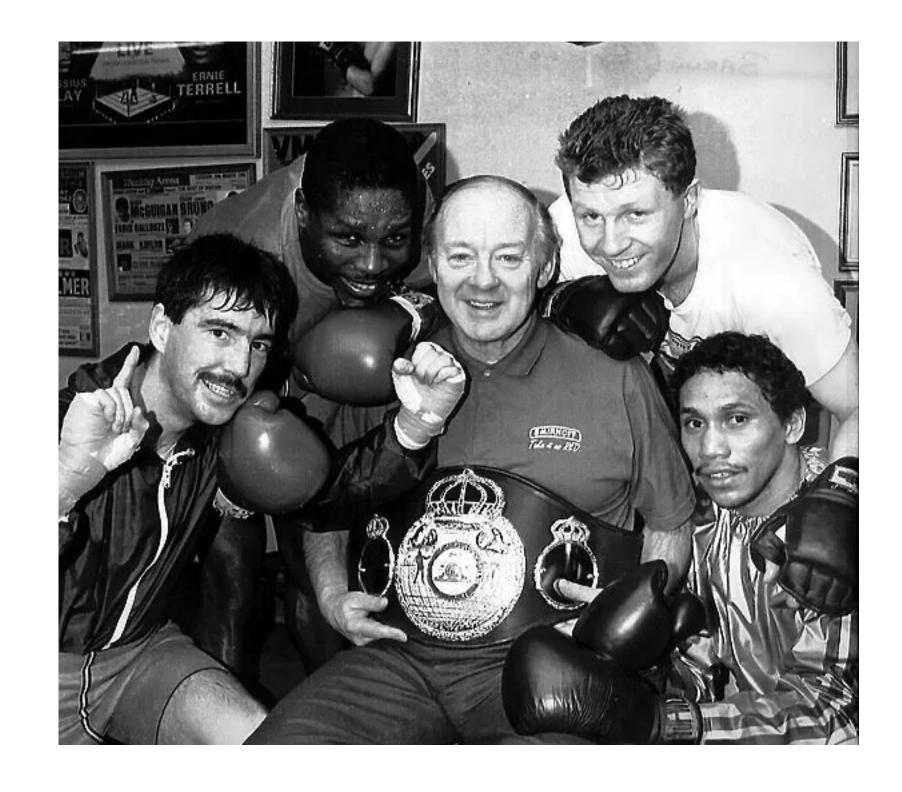

INCREASE INCOME FROM LICENSES

It is proposed to generate conditions that help increase income from licenses of promoters, judges, officials, etc.

This will have an immediate and direct economic impact on the WBA economy, but above all, it would aim to increase the base of allies in the region and the central office, which on the one hand should dilute the power of larger promoters, and on the other, must contribute to the purpose of promoting more boxing events and stimulating greater investment in boxing



DYNAMIZE WBA PROGRAMS

The WBA Regional Convention is proposed to become a venue for the regular implementation of WBA Central's global programs such as KO Drugs, WBA Academy, Future WBA Champions and WBA Legends.

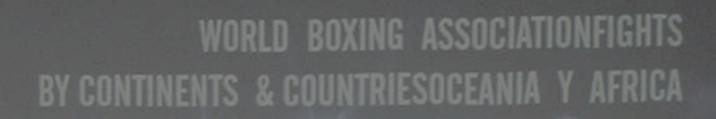
This gives regularity to these programs, but they will also give value and content to the Regional Convention, also offering tools to generate economic resources and training and competition scenarios.













The WBA academic program must be developed, forming alliances with local authorities, federations, clubs, universities, etc.

THE WBA ACADEMY SHOULD BE

Its execution can contribute not only to improving boxing; It can also provide WBA with a public relations, lobbying and income generation tool.



CONVENTION

Within the framework of the WBA Regional Convention, four days of activities are proposed, namely:

Day and a half for WBA Academy seminars and courses (judges and referees, doctors, etc.). by international instructors

Half a day for an Olympic boxing event, conducive to evaluating students of the seminars and courses.

Two half days for the convention itself.

Half day for social event (gala dinner, WBA Legends, auctions, etc.)

Half day for professional boxing evening
