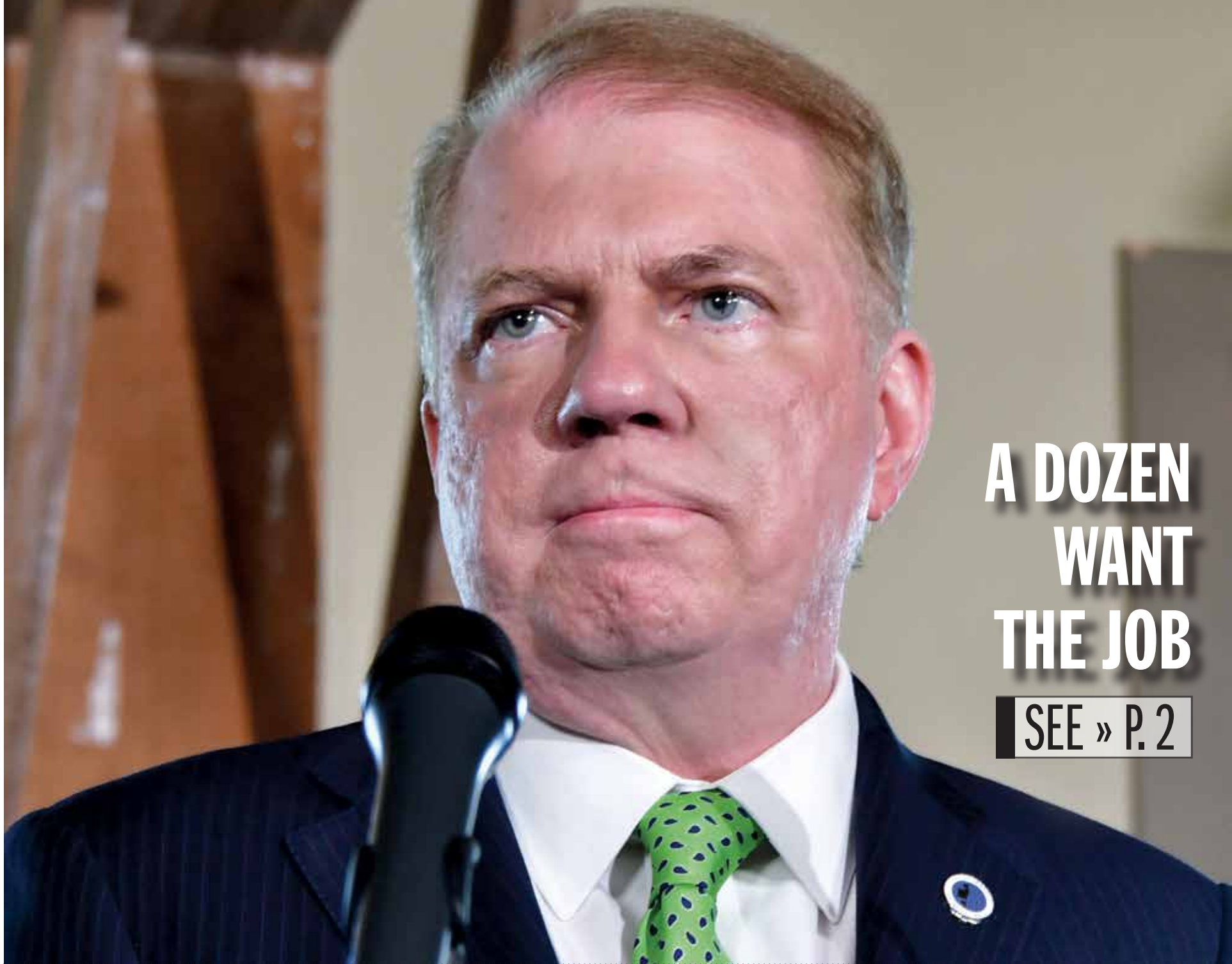

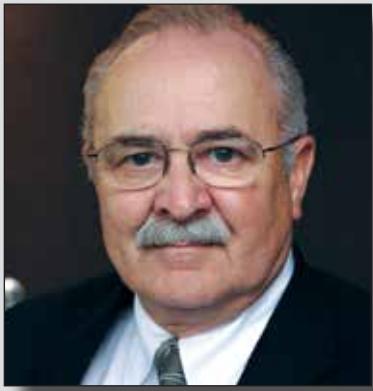

Fauntleroy Boulevard Project design at 90% complete; still taking community feedback

The \$20 million revamp of Fauntleroy project from SDOT has reached the 90% design stage but SDOT, showing due diligence, continues to share the latest feedback from the community and design updates. The most recent was a presentation before the West Seattle Chamber of Commerce on May 11.

Project Background

The Fauntleroy Boulevard Project builds upon previous planning work done by the community. Discussions of improvements to Fauntleroy Way began in 1999, when the West Seattle Junction Hub Neighborhood Plan identified streetscape improvements in this area, and continued through the multi-year West Seattle Triangle planning process. The community chose a preferred streetscape plan for the project in 2012, which was formally adopted by SDOT and the Seattle Department of Planning and Development. In addition, the 2014 Bike Master Plan designated Fauntleroy Way for a protected bike lane.

Through several extensive community planning efforts, the residents and business owners in the area have expressed the need for mobility improvements to make this stretch of Fauntleroy Way more com-

fortable for people walking or riding bikes, and highlight its role as a main entrance to West Seattle. That means two lanes of travel in each direction (as it is now) but new sidewalks, a landscaped center median, protected bike lanes and some public art.

The project goals are:

- Respond to community needs identified in the West Seattle Triangle Plan and the Bicycle Master Plan
- Improve mobility by organizing the street to be more predictable and comfortable for everyone: people driving cars or trucks, walking, or biking
- Enhance Fauntleroy Way's role as a key entrance to West Seattle
- The project area is on Fauntleroy Way between 35th Avenue S.W. and S.W. Alaska Street

Feedback from the community

SDOT has heard a lot of support for the mobility enhancement aspects of the project but that has been tempered by concerns about traffic. In response they did a revised traffic study on the removal of the right turn pockets at Avalon and Oregon Streets S.W. They've gotten a positive response for the landscaping plan which is being developed

with low maintenance and sightline preservation in mind. The planting strip and media will have Tupelo and Cedar trees, the planting strip will have Laurel and dogwood with Geranium and Iris accents.

There was interest expressed in having an additional cross walk included near 37th S.W. That matter is still under review but Norene Pen said thus far the suggested location is "too close" to 37th S.W. SDOT heard that there is interest in extending the improvements through the intersection at 35th Avenue S.W. That too is still under review.

Business access in the area is critical said respondents and SDOT will analyze left turn movements, explore parking management (time restricted zones) and look at driveway

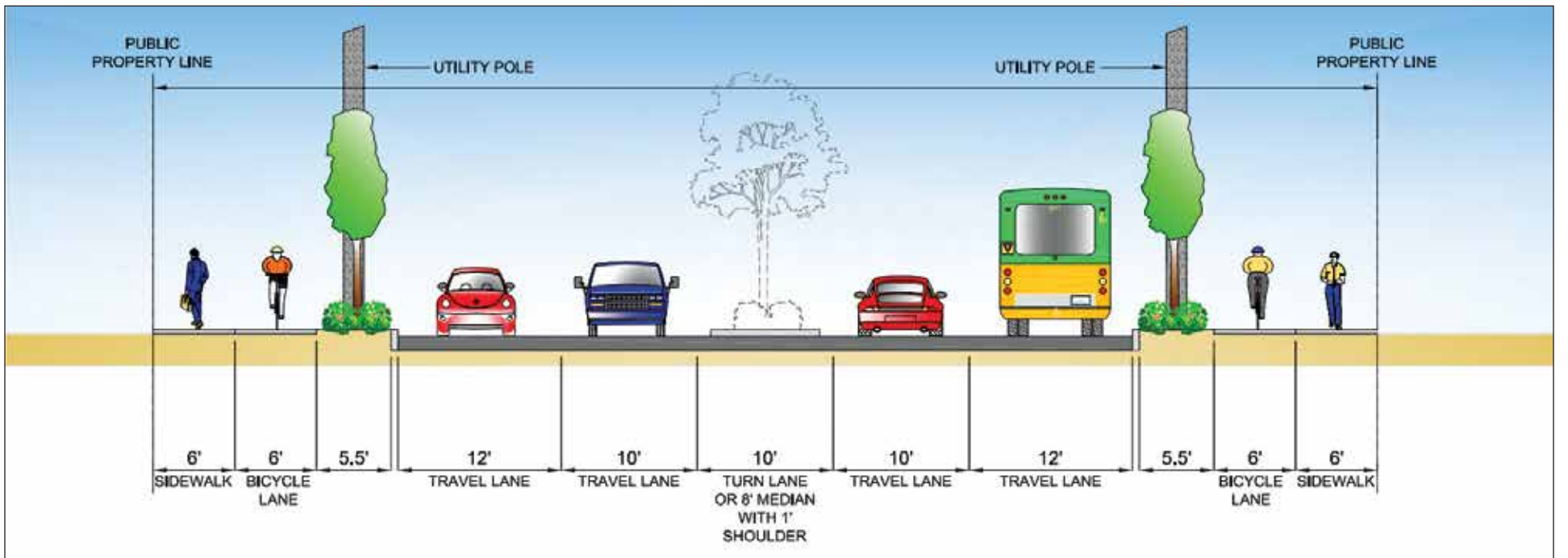
and load zone designs for each business.

Concerns about the length of construction and impacts on business and the surrounding neighborhood were also part of the community feedback. SDOT got 61 written comments from the Walk and Talk on site reviews conducted in March.

Traffic studies

A traffic study was done in 2014, but SDOT has been busy doing a number of new studies to update the data. The latest plan is to start construction in 2018 and be done the following year. They took new counts, looked at the projected traffic model for 2019 taking into account current new construction, permitted projects, figuring a 1 percent annual growth rate, the including of signal timing changes

Former Des Moines resident sentenced to 27 years in prison for production and possession of child pornography

Made Videos of Sexually Explicit Conduct with Sleeping Children

A former Des Moines man was sentenced last week in U.S. District court in Seattle to 27 years in prison and lifetime of supervised release for producing and possessing images of child pornography, announced U.S. Attorney Annette L. Hayes.

Robert D. Thorson, 58, was convicted following a four-day trial in February 2017. Thorson was arrested May 30, 2016, after his girlfriend called Des Moines police when she found sexually explicit images of minors on Thorson's phone.

At sentencing, Chief U.S. District Judge Ricardo S. Martinez said, "This is one of the most egregious cases this Court has handled. . . Mr. Thorson repaid the kindness shown to him [by two families] by sexually abusing and exploiting the children."

"This defendant sought relationships with women so that he could molest their children, said U.S. Attorney Annette L. Hayes. "He insinuated himself into the lives of the families he preyed on and when

his crimes were discovered, he threatened them from prison to try to get the charges against him dropped. There is no question that the public—and especially our kids—are safer as a result of the lengthy sentence imposed in his case."

According to records in the case and testimony at trial, Thorson's girlfriend examined his phone looking for evidence he was

seeing other women. Instead she found images of Thorson molesting young girls who resided in her home. The woman called Des Moines Police and Thorson was arrested. When investigators examined Thorson's electronic devices they found images showing Thorson disturbing the clothing and bedding of sleeping children so he could make sexually explicit photos. Thorson's clothing, tattoos and body parts appear in some of the images. Thorson's electronic devices also contained images from a hidden camera installed in a bathroom at the home that captured minor children using the bathroom and the shower. The electronic evidence presented at trial revealed Thorson preyed on a second family when he briefly stayed in their home in 2015.

In addition to the images of child molestation that he produced, Thorson also had images of other children being raped and molested that he collected from the internet. Thorson's electronic devices had 22 videos and 40 images of children being raped by adults. One two-hour video Thorson had on his electronic devices

shows the rape of a four-year-old child by an adult male.

While Thorson was in custody he sent letters to his former girlfriend threatening her and demanding she change her statements to police.

"Not only did Thorson violate innocent children as they slept for his own sexual gratification, he used threats and coercion in an attempt to cover up these heinous acts," said Brad Bench, special agent in charge of HSI Seattle. "In partnership with local law enforcement, investigators successfully presented the evidence needed for a jury to bring justice to this predator."

The case was investigated by the Des Moines Police Department and U.S. Immigration and Customs Enforcement's Homeland Security Investigations.

The case was prosecuted by Assistant United States Attorney Stephen Hobbs and Special Assistant United States Attorney Cecelia Gregson. Ms. Gregson is Senior Deputy Prosecuting Attorney specially designated to prosecute child exploitation cases in federal court.

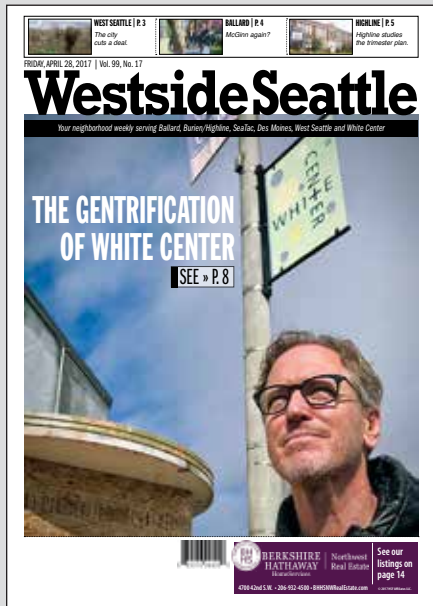

Sunset Barbershop to close after 100 years

What comes to mind when you think of a barbershop? To the men of the last generation, the barbershop was a clean, well-lit place where they came for a good grooming. And that's been the case for the Sunset Hill Barber shop for the last 100 years, but after the building where it operates sold, the shop is facing closure.

Dianne Riordan is owner of Sunset Barber at 6406 32nd N.W. She found out two weeks ago that the building where her barbershop operates was put on the market. After just two weeks of it's listing the owner accepted an offer. Now Riordan, a woman of retirement age, is facing the reality of losing her business.

Riordan has lived in Ballard since the early 1970s and has been running her shop for the last 25 years. In the last 100 years the shop has been owned by at least five other barbers. After Barber College, Riordan apprenticed and eventually took over the shop from Gene George. Riordan said that George was well known in the community for celebrating Halloween, offering giant-sized candy bars for the kids and Jell-O shots for the parents. Gene passed away five years ago, but Riordan keeps the

Halloween tradition.

Walking into Sunset Barber is like entering a curious collection of the past. Black and white photos of James Dean, Marylyn Monroe and the Beatles hang on the walls. A large steel weathered barber chair is at the center of the small room. Combs, clippers, blades, shaving brushes—all the tools and artifacts of the barber trade—line a large shelf affront a large mirror. Veterans, seamen, blue collared men and well-to-do's all beseeched the barber chair for their humble grooming.

To many young people the barbershop seems foreign, and Riordan said that's because the barbershop has slowly been replaced by salons, a trend that has been happening since the 70s. She said that the beauty parlors rebranded as salons and beauticians renamed as stylists as hair fashions changed. But, as of late, a much more tangible force has displaced barbershops and other small mom and popshops: development. Riordan pointed out that four shops in the Ballard area between 70 and 80-years-old have closed in the last two years due to development, which included Two and a Half Happy on 24th Avenue and Smitty's on 15th Avenue.

“To me the mom and pop shops are the backbone of the community. They are what make every neighborhood uniquely different from one another. ... Now it's all generic. No mom and pop shops can move in. There is no opportunity for those who are less fortunate. And this is not only our community this is nationwide,” said Riordan.

With losing the barbershop, Riordan says out goes a tradition and a place for where the men of old have a space of their own.

Riordan explained that barbershops are more than a place to get a shave and a trim.

“All these people I have the blessed opportunity to meet them from all walks of life—big wigs and working people. They want that experience and that links them to the past. In the barbershop it's more than just a place to get your haircut; it was a destination. You'd come in and shoot the shit with all the guys in here and I had a front row seat to listen to all the amazing stories, young and old.”

Jenny Durkan for mayor—former U.S. attorney ready to make a run for it

Jenny Durkan is confident that she has what it takes to run the City of Seattle.

“I will listen, I will learn and I will lead,” she said. “Please let me be your mayor.”

The former U.S. Attorney, who served in the Obama administration, announced her candidacy at a press conference in Beacon Hill on Fri., May 12. The election will be held on Tues., Nov. 7.

She is running against 12 candidates so far: Casey Carlisle, Michael Harris, Bob Hasegawa, David Ishii, Harley Lever, Mary Juanita Martin, Michael McGinn, Cary Moon, Nikita Oliver, Jason Roberts, Alex Tsimerma, Jessyn Farrell and Keith Whiteman. Mayor Ed Murray announced on Tues., May 9 that he would not seek re-election.

A couple of prominent West Seattle figures were present among the many faces of supporters endorsing Durkan, including King County Council Chair Joe McDermott.

“I’ve known Jenny for over a decade, and I’ve worked with her on a lot of causes -- from LBQT issues to police reform here in the city,” McDermott said. “I know her to be a passionate and progressive leader, and I’m excited about her candidacy.”

Former city council representative Tom Rasmussen, a resident of the Alki neighborhood, was also at the event to show his support.

“I think she’s extremely well qualified and knows Seattle issues,” Rasmussen said. “I’m

confident that she can and will lead police reform as she did as U.S. Attorney. West Seattle is an incredibly diverse neighborhood. She brings strong values and has a moral commitment to helping low income residents, seniors and children.”

Durkan named police reform and increased accountability among the top priorities she would address as mayor, along with finding solutions for homelessness and increasing affordable housing options.

“Seattle is my home, and it has helped make me who I am,” Durkan said. “I love this city and its quirky, irreverent and engaged people.”

She talked about watching the construction of the Space Needle as a child.

“The theme of that World’s Fair was the future,” she said. “And Seattle has embraced the challenge.”

While Durkan commended the city for its progressive approach to marriage equality and seeking gun reform, as well as its industry, technology and business growth, she said Seattle needs to do more to promote equality.

“We are the city that is inventing the future,” she said. “Today Seattle has shiny new towers and an innovate economy. We’re also a city caught in shifting times. In too many ways, for too many people, our incredible successes are also creating two Seattles. Two many people are being locked out. They cannot compete with rising prices.”

Durkan said the cost of a first home, rent-

al rates and property taxes have become too much for most people in the city – and that too many residents are now living in tents and cars on the streets.

“I am running for Mayor because I believe we can bring light and love to those shadows,” she said. I believe we can reweave our frayed social fabric. I believe we can solve the problems we face, if we tackle them together.” Durkan has already been a light for many causes. She was appointed by President Barack Obama in 2009 as the U.S. Attorney for Western Washington and became the first openly gay U.S. Attorney in the country’s history.

In that post, she led efforts to reform the Seattle Police Department and created a civil rights unit to prosecute hate crimes, housing discrimination and issues facing returning veterans.

In addition, Durkan helped Washington cut down opioid abuse and violent crime, increasing gun prosecutions by 45 percent. She also chaired efforts to address cyber-crime and consumer privacy. As Mayor, Durkan said in addition to facing her top concerns, she would also make city services a top priority. “The basics matter first,” she said.

She recognized that in the current political climate, there are a number of challenges for a progressive candidate.

“I want everyone to know that Donald Trump’s vision for America is not my vision for America, and more importantly, it’s not the City of Seattle’s vision for America,” she said. “Neither Donald Trump, nor his im-

migration authorities nor Jeff Sessions is going to tell us how to run our city . . . I can promise you, they do not want to pick a fight with me.”

Durkan was part of a team that fought President Trump’s Executive Order on immigration, resulting in the judicial order preventing people from being deported from SeaTac airport.

She also served as a criminal defense and plaintiffs’ attorney, winning the 2005 recount lawsuit brought by Republicans to unseat Democratic Governor Chris Gregoire. Durkan pledged to protect the environment, science and healthcare, as well as promote a vibrant economy and small businesses.

“It’s ambitious,” she said. “Can we do all of this? Yes, we can, and we must. We need leadership to get beyond the noise, bring people together and find real solutions. As your mayor, that’s what I’d like to do.”

Durkan was born and raised in Washington State. Her parents are former State Senator Martin and Lorraine Durkan. She and her partner Dana Garvey have two teenage sons.

Durkan served on the Washington State Bar Association Board of Governors, the Merit Selection Committee for the U.S. District Court, the board of the Center for Women and Democracy, the board of the Seattle Police Foundation and as chair of the Washington State Attorney General’s Task Force on Consumer Privacy. MAN ARRESTED FOR FIRING GUN IN PARK

Around 11:30 p.m. on Wed., May 10,

Officer Stephanie Hemsley was patrolling near Roxhill Park, near 29th Avenue S.W. and S.W. Barton Street, when she heard gunshots. She searched the area—and soon saw a couple running towards a parked gray Pontiac. Officers stopped the vehicle, discovered a handgun sitting on the floor under the driver's seat and found bullets in the man's pocket. The 25-year old man admitted to firing multiple rounds inside the park, and he was booked into King County Jail for discharging a weapon within city limits and for a concealed weapons violation. Officers released the woman from the scene, since she had not discharged the firearm.

He did not get hit by the rocks but still wanted to document the incident and file a report with police.

and obviously traffic to and from the Fauntleroy Ferry. Those studies showed an average delay in the morning of approximately one minute through the area. The evening commute transit time through the project area would increase by around 30 to 45 seconds.

Left turn access and the center median

One bone of contention mentioned by several people at the public forums held by SDOT has been the center median and left turn access to businesses on the street.

That led to a variety of options for breaking up the median, providing gaps that would let drivers turn from a center lane. The exact length and location of those gaps is yet to be determined.

Construction planning

Construction planning means considering traffic flow and the plan comes down to two options. Two lanes either direction or two lanes heading Southwest only coming into West Seattle. Traffic headed northeast

would be detoured to Alaska Street SW and subsequently to 35th SW. The first option would save three months of construction time according to SDOT. Also part of construction planning is minimizing construction impacts in the area. Asking workers to park in an offsite designated area, controlling parking areas with time limits, limiting on-site equipment staging, and providing way finding business signs and maps are all part of the plan.

Working with businesses.

Mikel Davila (formerly with WCCDA in White Center) is now part of the Office of Economic Development and running point on helping businesses in the construction area. The office offers free business consulting, restaurant assistance, advocacy during permitting processes, and financial consulting. Dozens of West Seattle businesses have used the services according to Lynn Dennis of the West Seattle Chamber of Commerce.

Next Steps

Through May the project team is taking feedback, especially on the left turn breaks

in the center median. In June they will review the final driveway designs with local businesses. In late June or July the design will be complete and a final decision will be made on the left turn breaks. Later in the summer pre-construction coordination will take place and parking management discussions will take place. Then early in 2018, construction will start continuing throughout the year until completed in 2019.

Questions about parking for businesses

Two businesses, Rudy's Barbershop and Real Fine Coffee will lose their on street parking spaces. There was some question about the permits on those parking spaces and SDOT responded.

"We also looked into the individual building permits for this particular property. The original plans for the building permit established no off-street parking—the building was originally a gas station, and the curb cut led to the gas pumps and service bays. The next permit for the building is 2014, changing the use of the structure to

a barber shop and coffee shop. This permit established no off-street parking, and no off-street parking is required by city code for this type of change.

Aerial photos show that sometime in the 1990's the front portion of the site was striped to be used as off-street parking.

This type of change technically requires a permit from the City Department of Construction and Inspections (SDCI, formerly DPD). There is no permit on file, meaning the parking was never reviewed or approved by SDCI. Any formal addition of off-street parking moving forward would be subject to the development standards in the Seattle Land Use Code and review and approval from SDCI."

This Friday is the deadline. That deadline—last day to file for office—could draw more than the dozen candidates already running for mayor of Seattle.

The weeks preceding the filing deadline have been unsettling. What had once seemed a quiet municipal election has been upended—first by lurid allegations and maneuvers and then by incumbent Mayor Ed Murray’s stunning decision not to seek a second term.

Now, with the August 1 primary only 11 weeks away, citizens must seriously consider who can best govern Seattle. What’s at stake is electing someone with the management skills to keep Seattle running, to keep it vital and functional for all its residents.

As the late Councilmember Richard McIver, my one-time mentor at Seattle

Who can govern Seattle?

City Hall, once asked, “Did your alarm wake you this morning? Did you have a hot shower? Was there water for your coffee? And did your bus arrive and deliver you on time to your job?”

McIver wanted constituents to think about the basics: Is the city working? Is there electrical power? Clean water and trash pickup? Are streets passable and the transit system reliable? Are police and fire services available and on call? Are libraries, parks and community centers operating and open to all? Is the city tending to the homeless and unsheltered?

These are the core needs that citizens cannot provide for themselves. Availability of reliable services is the main reason we choose to live in cities, and we want to elect a mayor who can tend to those basics but who can also lead. If I had to devise a checklist for mayor candidates—skills necessary for the city to succeed—I would look for these essentials:

Respect for Seattle values: A good mayor must have a feeling for Seattle’s brand, keeping this city true to its can-do spirit, embracing new ideas while not discarding old ones. Ensuring government transparency and encouraging citizen input are part of that respect. So, too, is cherishing the city’s 90 distinct neighborhoods. These neighborhoods should not—must not—be allowed to smother under brittle newness and mindless density.

Dedication to justice: The mayor’s top job is to oversee the police and fire departments. These services command the lion’s share—some 65 percent—of the city’s budget and are essential factors in how the city relates to its citizens. Are the city’s streets safe? Is policing fair and nondiscriminatory? Is there effective citizen oversight? Are emergency services fast and efficient?

Stewardship of resources: The city’s infrastructure and assets require constant attention. That means timely upkeep of roads, bridges and sidewalks. It means overseeing Seattle City Light, the nation’s greenest electrical system, and Seattle Public Utilities with its pure water and enlightened approach to recycling and drainage. It means full support for the much-admired Seattle Library and for the city’s Metropolitan Parks system, the 465 parcels that occupy 11 percent of city lands.

Business acumen: Each year the mayor sends a proposed budget to the City Council for approval and revision. Together the mayor and council must make sure funds are spent wisely and appropriately. Again quoting the late Richard McIver: “You don’t have the right to take scarce city resources and squander them on pet projects.” (Think Pronto.)

Political muscle: When needed, the mayor must defend Seattle against the Trump administration’s misdirection on immigration, refugees, federal funding

and health care. The city has been taking vigorous positions. There should be no relaxation of that willingness.

Compassion: The mayor must work to alleviate conditions for the less fortunate. When so many are being priced out of city living, the mayor must be able to imagine walking in the shoes of the dispossessed, homeless, hungry and halt.

Vision of the future: At a time when private forces are making grand plans for stadiums, business complexes and community redevelopment, the mayor should have staunch goals. Those goals must benefit the entire city and not piece-meal our way into an uncoordinated topsy-turveyland.

Ability to unite: A mayor should be capable of bringing together labor, industry, business and community. What’s needed is the talent to reconcile perspectives and reach agreement. A good mayor must convene, facilitate and clarify diverse thought.

This is a daunting list, maybe not completely achievable. But this is Seattle; and, with luck, we will search out, find and elect the talented individual who can best govern our city.

Historical society to seek new executive director

After four-plus years of leadership, Clay Eals steps down from post

The Southwest Seattle Historical Society soon will seek a new executive director to succeed heritage advocate Clay Eals, who has resigned after four-and-a-quarter years in the position.

In a letter to the organization’s board, Eals wrote that his decision to step down stems from “a desire to spend more time focusing on other aspects of my life.”

His departure will be effective in mid-July. The board plans to begin advertising for the full-time position later this month and hopes to fill the

position in time for the successor to overlap with Eals, who has been involved with the historical society since its founding in 1984.

Eals became the historical society’s first executive director in January 2013. He expressed gratitude for the opportunity, adding that he is confident that the organization’s mission, track record and board leadership will result in continued organizational success.

The author, historian and ex-journalist wrote in his resignation letter that the timing of the transition would be “as good as it gets” for the organization. *Information provided by Southwest Seattle Historical Society*

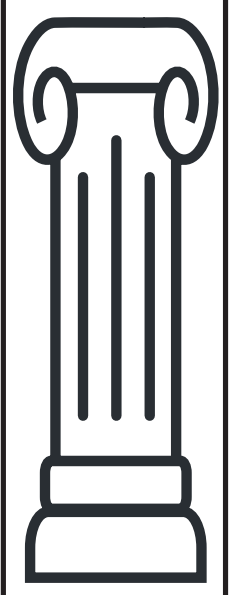

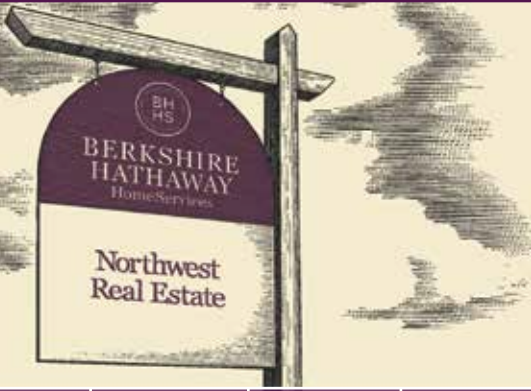

There's that adage that you can't choose your family, but you can choose your friends. For thirty years I've chosen Seattle as my hometown. But I do love to visit because it seems like time travel, from the October when I was there for the pumpkin weigh-in to ice-skating on New Year's Eve.

Within hours of my landing in late April I was helping my sister host 14 teenage girls

My favorite overheard line from the Co-Op was the woman asking the clerk about feeding her lawn. "I have a very big lawn," she said. How big he asked her.

"Forty acres," she said, "but really the lawn part is just one acre."

I told you it was different than Seattle.

Meanwhile the town was making the most of removing what they claimed to be the second oldest tree in town, with Girl Scouts, naturalists and those running for local office in attendance. Alas, the tree didn't appear to be as diseased as expected once cut, but on the bright side did not hit the 1650 Parson Capen House when the main trunk was airborne.

I confess to using the distractions of New England life to buffer the news from Seattle. When word came that the building where Walter's Café has operated since 1990 was for sale I willed it away like a child who thinks they are invisible because their eyes are closed. Yet when I got my weekly "This Week in the Mayor's Office" email I couldn't help but notice that he was also filtering news; Murray made no mention of having ended his campaign for re-election.

Well, I'm back. Ready to plant the heirloom tomatoes from Abundant Greens and be in Pacific Time. I'm also ready to learn more about local architect and planner David Moerhing's outreach and efforts to balance Ballard's growth with historic preservation, with a follow-up meeting on Thurs., May 18, from

7-8:30 p.m. at Bauhaus Ballard.

I'm in time for a taste of local asparagus and the last croissants made personally by the owner/founders of Café Besalu (before they move to Besalu, Spain and their bakery changes hands). There's been a lot of change in my three weeks out of town, but it's time to admit that with or without a time difference, change is our constant. And baby chicks grow fast.
